Saturday, July 4, our country will be observing the 239th anniversary of the Declaration of Indepen-

The first draft of the Declaration of Independence was prepared by Thomas Jefferson. On July 4, 1776, Jefferson's Declaration of Independence was adopted which proved to be a vital document.

A committee of five people, Thomas Jefferson, John Adams, Benjamin Franklin, Roger Sherman and Robert R. Livingston, prepared the document.

Jefferson prepared the first draft and on July 4, 1776, Congress formally adopted Jefferson's Declaration of Independence. A few days later the text was read publicly in Philadelphia, and copies soon became available to all Americans.

The document said. "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their creator with certain unalienable Rights that among these are Life, Liberty and the Pursuit of Happiness."

The Fourth of July is one of my favorite holi-

days. I have fond memories of my childhood years celebrating the day with my mom's relatives in Island Park in Rock Rapids, Iowa, and McKennan Park in Sioux

To this day, both of these parks are favorites of mine to visit. At night we usually attended fireworks in Luverne.



Buffalos bow out of playoffs

The Tri-State Buffalos bowed out of the Southern Plains Football League Playoffs Saturday in Cleveland.

The Buffalos turned in a competitive performance against The Panic, but it wasn't enough to keep their 3-5 season from coming to an end.

The Panic sported a 21-19 lead after 24 minutes of play and outscored the Buffalos 14-6 in the second half to secure a 35-25 victory.

Tri-State fell behind 9-0 early in the game before quarterback Alex Toupal threw his first of three touchdown passes of the game to make it 9-6.

Toupal hooked up with Richard Gonzalez for a 15-yard strike.

The Buffalos trailed by two (15-13) when Toupal tossed a 15-yard touchdown pass to Weston Petersen, and the difference remained at two points (21-19) when Wyatt Stepka scored on a 10-yard touchdown run late in the first half.

The Buffalos made it a two-point game (27-25) when Petersen hauled in a 30-yard touch down pass from Toupal with four minutes remaining in the fourth quarter, but The Panic added a late touch down and a two-point conversion to ice a 10-point victory.

ness to consideration for others (which isn't all bad but still dishonest).

It is a wonderful turn of events and a delight to hear our nearly 8-year-old's innocent, albeit mildly selfish reason for faking that makes complete sense. I hope you have had the chance, at least once in your life, to fake-sleep in the car and have your dad or grandpa carry you kind of like a baby into the house. It is Kaiden's and my favorite feeling in the world.

I'll close the gate and treasure my favorite feeling I recall from when I was just a tike.

I imagine that's what being carried off to Heaven by our Father is going to be like.

Descendants of Rose and John Moser gather for family reunion in Hills June 6

Descendants of John and Rose Moser gathered for a reunion at the Hills American Legion Saturday, June 6, with 166 attending — some coming from as far away as Kansas and Illinois

The gathering takes place every three years. At this year's event a meal was served by Tony's Catering, with a silent auction to raise money for the expenses of the next reunion. Memorabilia of the Moser family was also displayed at the event.

John and Rose (Kellenberger) Moser were united in marriage Dec. 20,1916, in Seneca, Kansas.

Approximately 1 1/2 years later they made the decision to move to the Lester, Iowa, area. Three or four of Rose's brothers were already living there and had reported better farming conditions in Iowa.

At that time the best way to move was by rail. Their household belongings, their riding horse, Babe, and the buggy, two cows, a few crate of chickens, and a few farm implements were loaded into a freight car of the Rock Island Railroad.

John rode the entire way (about 280 miles) with the freight so as to take care of the animals and also to keep watch over their personal belongings. Rose and her older sister, Martha (Mrs. Herman Wiese), rode in one of the passenger coaches.

Their first home was the farm place 1/4 mile west of Lester on Highway 9. One of John and Rose's grandsons, Wes Moser, and his family now live on the farm.

After moving to another farm 2 miles west and 1 mile south of Lester for a couple of years, they made one more move, this time to a farm 3 miles south and 1 3/4 miles west of Hills, where they lived (and were still living at the time of John's death) for 57 years.

Their youngest son Frank now lives on the farm. Of John and Rose's 13 children, all but three were born in the farm home and all of them attended school at Larchwood Township No. 2.

Rose made many trips into Hills with her horse and buggy and one or two small children beside her. In the back of the buggy was usually a crate of eggs, which they would trade for groceries at the Hills Mercantile, a general store.

Other business places in Hills at that time were Pete Nickel's Harness Shop, Adolph Kirsch's gas station, Chris Sjolseth's Chevy Garage, two hotels, dence, where one of John and Rose's granddaughters, Sandy (Ron) Feucht, lives today.

There was also a Dr. Haug, whose kitchen table doubled as an operating table when one of their daughters needed her tonsils removed. This operation took place in the house now owned by Mark and Marie Opheim.

The Mosers also had two sad occasions to use the undertaking service which at that time was located in Christians' Furniture Store in Hills, the building where Hills Locker Service owned by Tedd Larson is presently located.

On July 18, 1927, their 14-month-old son, Donald Hal, fell into the stock tank (which all farms had then for watering livestock) and drowned. On Aug. 1, 1935, their 13-year-old son, John Nicholas, died from a ruptured appendix in the Luverne Hospital.

John and Rose had two other sons who died. Their firstborn child, a boy, lived only a few minutes, and their third son, Harry, was killed in action on the Philippines island of Luzon during World War II at the age of 21.

John Moser passed away on March 5, 1977, following a short illness at the age of 83. Rose Moser passed away in 1995.

John and Rose were parents of **Milford**, deceased; **Mariann**, married to Elmer Metzger, both in the Tuff Memorial Home in Hills; Ione (deceased), married to John DeHaan (deceased); John (deceased); Harry (deceased); **Leo** (deceased), married to Leona Mogler, Rock Rapids, Iowa; Donald (deceased); Betty (deceased), married to Paul Leuthold (deceased); Estelle, Hills, married to Alvin Leuthold, (deceased); Frank**lin,** married to Verna Mogler (deceased), Larchwood, Iowa; **Evelyn,** married to Roy Metzger, Bloomfield, Iowa; **Donna.** (deceased) married to John Gerber (living), Doon, Iowa; and Janet, married to Jack Wysong (deceased), Hills.
